I have received a notice of dissolution from your department. I believe this form was sent in error, and I have sent correspondence to your department before in regards to this matter. This corporation sent the required documents and payment on time. Due to a banking change, the money was sent in the form of a postal money order, rather than company check. The account number was noted on this money order, in case the form and money order were separated.


This seems to be an ongoing problem with either the postal service or your internal mail-handling not getting the paperwork in properly, as it has happened twice already in the past few years.

In view of the difficulty in offering a canceled check due to using a money order, I am offering the following compromise since it is difficult for either one of us to proof anything was sent or not received. We can send in an actual check for the **original** amount due for the registration fee, and in effect pay twice for this year.

If this is not satisfactory to your department, we shall simply allow the company to remain dissolved, as it is not currently being used to conduct business.

We would strongly suggest getting your forms and filing on the Internet as soon as possible, to make this process easier and trouble free. This would eliminate the US Postal Service as a factor in getting forms in, as it is widely viewed as an unreliable and incompetent organization by many of its customers.
