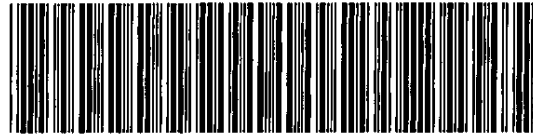

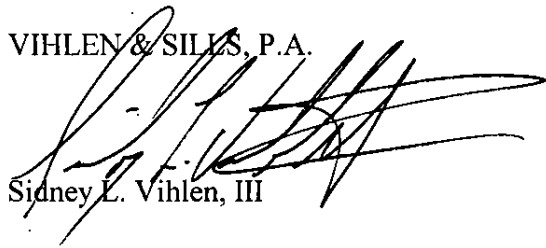

VIHLEN & ASSOCIATES, P.A.

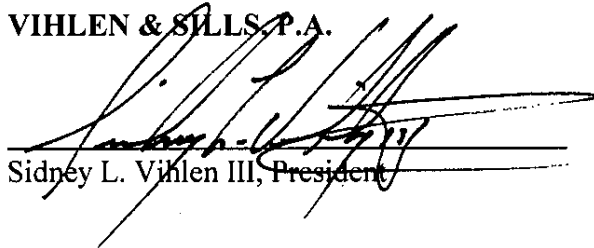

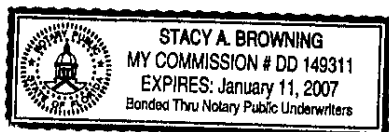
