11. *Chlorophyll *a* and *b* content* were determined by the method of Lichtenthaler and Whaley (1987). The chlorophyll content was determined by measuring the optical density of the chlorophyll extract at 663 and 646 nm. The chlorophyll *a* and *b* content was calculated using the following formulae: Chlorophyll *a* (mg g⁻¹) = 12.7 (OD₆₆₃ - 2.13 OD₆₄₆), Chlorophyll *b* (mg g⁻¹) = 22.9 (OD₆₄₆ - 0.21 OD₆₆₃).
