Table 10 shows the results of the analysis of the data obtained from the 2006 GobitP trial. The results show that the average yield of the control treatment was 3322 kg/ha, while the yield of the experimental treatments ranged from 3180 to 3220 kg/ha. The highest yield was achieved by the treatment with 100% Gossypium hirsutum L. (3220 kg/ha), followed by the treatment with 50% Gossypium hirsutum L. and 50% Gossypium barbadense L. (3200 kg/ha). The yield of the treatment with 100% Gossypium barbadense L. was slightly lower than the control treatment (3180 kg/ha).
