Pursuant to the provisions of Sections 607.1003 and 607.1006 of the Florida Statutes, THE MEDICAL STORE OF ORLANDO, INC. adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is THE MEDICAL STORE OF ORLANDO, INC.
2. The original Articles of Incorporation for the corporation were filed on November 14, 1994 and assigned Charter No. P94000083908.
3. By written consents executed on February 4, 1998 by all of the Directors and Shareholders of the corporation, respectively, the Directors and Shareholders have agreed that the Articles of Incorporation be amended to change the name of the Corporation to "TOTAL MEDICAL SOLUTIONS, INC.." The amendment was approved by the single class of Shareholders and the number of votes cast for approval was sufficient.
4. Article I of the Articles of Incorporation is hereby amended to read as follows:

ARTICLE I - NAME

The name of this corporation is TOTAL MEDICAL SOLUTIONS, INC.
