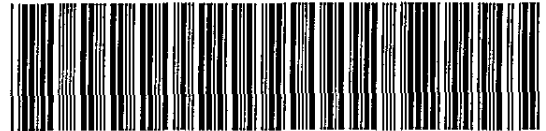




The following Plan of Merger is submitted in compliance with section 607.1101, F.S. and in accordance with the laws of any other applicable jurisdiction of incorporation.

First: The name and jurisdiction of the surviving corporation:

Third: The terms and conditions of the merger are as follows:

Sunlight Trading, Inc. shall merge into H. D. Knitting, Inc. As a result of this merger H. D. Knitting will thereafter own of all the assets formerly owned by Sunlight Trading, Inc. and shall thereafter be liable for all debts and obligations of Sunlight Trading, Inc. On completion of the merger Sunlight Trading, Inc. shall cease its existence.

Knitting, Inc. following the merger as such shareholder held in Sunlight Trading, Inc. prior to the merger.
