



TO THE ARTICLES OF INCORPORATION OF

Pursuant to Sections 607.1003 and 607.1006 of the Florida Business Corporation Act, the Articles of Incorporation of CLEAR IMAGE PRODUCTIONS, INC., (the "Corporation"), are hereby amended as follows:


FIRST: The name of this Corporation is CLEAR IMAGE PRODUCTIONS, INC.

SECOND: Article I of the Articles of Incorporation is hereby deleted in its entirety and the following inserted in lieu thereof:
