**ARTICLES OF AMENDMENT  
TO ARTICLES OF INCORPORATION OF  
UNGER, SWARTWOOD, LATHAM & WHITAKER, P.A.**

1. That the current name of the Corporation prior to October 1, 1997, was Unger, Swartwood, Latham & Whitaker, P.A.
