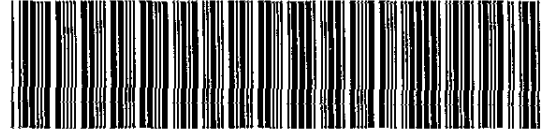

If you no longer wish to be authorized to transact business in Florida, you may file an Application For Withdrawal of Authority to Transact Business in Florida. The fee for filing a withdrawal is \$35. If in the future you wish to again be authorized to transact business in Florida, you would have to file new qualification documents with this office.
