## ARTICLES OF AMENDMENT OF THE ARTICLES OF INCORPORATION OF HIERS FUNERAL HOME, INC.

# OS OFF LED OF STATE

#### Article I - Name

The name of this Corporation is HIERS FUNERAL HOME, INC.

### Article IV - Capital Stock
