Dear Sir or Madam:

I am writing this letter to appeal the assessment of the \$400 late fee for filing the UBR.

On April 27, 2000 I tried to utilize the automated system for filing my UBR per the instructions that accompanied my CR2E034 form. I tried numerous times from April 27th to April 30th to access the www.sunbiz.org site to file my UBR. Each time I was unable to get into the UBR Filing pages to file the report. On April 27, 2000 I emailed your office at ubrcorp@mail.dos.state.fl.us to get assistance with this problem. My emails were returned with error messages (I have included one for your reference). I also tried calling the 850-488-9000 telephone number several times for assistance. Each time I received a message that informed me that "Our computer system is temporarily down – please call back in one hour."

I tried again to access the site on Saturday, 29 April, 2000 and again on Sunday, 30 April without success. At that point I realized that the form would be late if I mailed it and I stopped trying to reach you and set the forms aside, with the intent of calling on Monday, May 1st to resolve the problem. All this was happening at a time when I thought that I would be moving my residence, so I was packing all my documents for transport. As a result, the form was misplaced until I found it on Jun 6th and sent it in.

While I understand that I misplaced the form, I believe that the fact that I made a considerable effort to report in a timely manner and repeatedly tried to contact your office from April 27, 2000 through April 30, 2000 by phone, email and web access without success prevented me from filing the form when I had intended to and contributed to the late filing of the UBR. The lack of accessibility of the automated system and phone support prevented me from processing the form on April 27, 2000 as I had intended.

For these reasons, I feel that the \$400 late fee should not be assessed in this case.
