ARTICLES OF AMENDMENT OF THE ARTICLES OF INCORPORATION OF CONCEPT 2 MARKET, INC.

Pursuant to the provisions of Section 607.1006, Florida Statutes, the undersigned Florida Profit Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the corporation is Concept 2 Market, Inc.
- 2. The following amendment of the Articles of Incorporation was adopted by the shareholders of the Corporation on the 1st day of November, 2007, in the manner prescribed by the Florida General Corporation Act:

Article 4 of the Articles of Incorporation of Concept 2 Market, Inc., which were filed on December 8, 1994, and amended on February 23, 2004, is hereby deleted in its entirety and is amended to read as follows:
