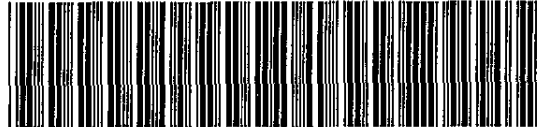

**ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION**

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, Small Wonders of Orlando, Inc., a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE I: The Articles of Incorporation of the Corporation hereby is amended by striking in its entirety Article 1 and by substituting in lieu thereof the following Article 1:
