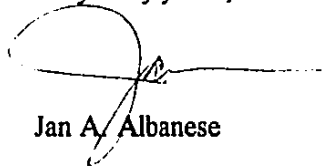

**ARTICLES OF VOLUNTARY DISSOLUTION OF CORPORATION**
