ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF PORTER ASSOCIATES, INC.

Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation.

ARTICLE I AMENDMENT ADOPTED

Amendment Adopted: Article IV of the Articles of Incorporation of Porter Associates, Inc., filed in the Office of the Secretary of State on December 19, 1994, is hereby deleted in its entirety and the following Article IV is substituted in its place and stead:

ARTICLE IV CAPITAL STOCK

Capital Stock: The aggregate number of shares of capital stock which this Corporation shall have authority to issue shall be Ten (10) shares of Voting Common Stock, each with a par value of Five Dollars (\$5.00) per share, and Two Thousand (2,000) shares of Non Voting Common Stock, each with a par value of Five Dollars (\$5.00) per share. The holders of the Voting Common Stock and Non Voting Common Stock shall have the same rights, privileges and powers, including but not limited to the right to participate in dividends, except that the holders of the Non Voting Common Stock shall have no voting rights and all voting rights shall be vested exclusively in the holders of the Voting Common Stock

ARTICLE II EFFECTIVE DATE

Effective Date: The effective date of this Amendment to the Articles of Porter Associates, Inc. is January 1, 2006.

ARTICLE III IMPLEMENTING AMENDMENT

Implementing Amendment: The foregoing amendment shall be implemented by all shareholders of Porter Associates, Inc., surrendering to the Board of Directors all of their respective shares of stock in Porter Associates, Inc. and receiving in exchange for each share of stock surrendered twenty (20) shares of Non Voting Common Stock and one-tenth (1/10) of one share of Voting Common Stock, all with a par value of Five and No/100 Dollars (\$5.00) each.
