## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF SUN COAST DELIVERIES, INC.



Pursuant to Section 607.1006 of the Florida Statutes, SUNCOAST DELIVERIES, INC., a corporation organized and existing under and by virtue of the laws of the State of Florida (the "Corporation"), does hereby certify:

FIRST: Name. The name of the Corporation is Sun Coast Deliveries, Inc.

**SECOND:** <u>Amendments Adopted</u>. The amendment adopted provides for the Corporation to
