

Pursuant to the provisions of section 607.1006, Florida Statutes, this corporation adopts the following articles of amendment to its articles of incorporation:

**FIRST:** Amendment(s) adopted:


- A. ARTICLE 1 - NAME. Article 1 is hereby amended to reflect that the name of this corporation is **St. John & Landon Financial Services Corporation.**
- B. ARTICLE 2 - PRINCIPAL PLACE OF BUSINESS. Article 2 is hereby amended to reflect that the principal place of business of the corporation is 1640 NW Boca Raton Boulevard, Boca Raton, FL 33432.
- C. ARTICLE 3 - MAILING ADDRESS. Article 3 is hereby amended to reflect that the mailing address of the corporation is 1640 NW Boca Raton Boulevard, Boca Raton, FL 33432.
- D. ARTICLE 4 - PURPOSES AND POWERS. Article 4 is hereby amended in its entirety to reflect that this corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida, including but not limited to accounting, management, financial, operating, and administrative consulting services, insurance services, investment services, loan packaging, business restructuring, systems consulting and any and all business activities related thereto.

- H. ARTICLE 12 - RESTRAINT ON ALIENATION OF SHARES.  
Article 12 is hereby deleted in its entirety.
