WE ARE SUBMITTING OUR 2002 UBR REPORT AFTER THE MAY 1, 2002 DUE DATE. I COMPLETELY FORGOT ABOUT IT DUE TO SEVERAL FACTORS. MY WIFE WHO NORMALLY HANDLES THESE MATTERS HAS BEEN SERIOUSLY ILL HAVING HAD OPEN HEART SURGERY AND SEVERAL COMPLICATIONS SURROUNDING HER ILLNESS. I TRIED DESPERATELY TO KEEP UP, BUT I MISSED ON THIS MATTER. WE ARE A SMALL CORPORATION THAT MANUFACTURES FURNITURE AND EQUIPMENT FOR SOME OF THE PUBLIC SCHOOL DISTRICTS HERE IN FLORIDA. I WOULD APPRECIATE ANY CONSIDERATION YOU CAN GIVE, IN WAIVING THE LATE FILING PENALTY. WE HAVE NOT BEEN LATE IN THE PAST AND WILL NOT IN THE FUTURE.
