As of April 29, 2002, we still had not received our Uniform Business Report. This seems to be a recurring problem with the Florida Department of State with us every year for the last three years. It seems you cannot maintain our current physical business address, even though we notify you of our address changes, along with the U.S. Postal Service. This year again, I had to call the Division of Corporations, to see what they had as our business address. Well, they replied, 259 Cory Ave, St. Pete Beach, Florida, 33736-6368. Gentlemen, we have moved from that address three and a half years ago!

Even though last year, when we again did not receive our Uniform Business Report for filing, I explained our problem in not getting the documents we need to file. Your employee give me a phone number to call to update our address, it was an automated message system. I called the number and followed instructions and at the beep, I gave all our current address information, hoping this would solved our problem. Apparently, it has not, since we still have not received our filing documents.

Therefore again today, (April 29, 2003), I called the Division of Corporations and was informed our Company is no longer registered in the State of Florida. He agreed, concurring that failure to submit our report was not entirely our singular fault. He went on to say he would not access any penalty fees, if I followed his instructions. He also requested that I mail my letter of explanation and a check for \$450.00 for the three years we apparently are in arrears.
