Pursuant to the provisions of Sections 607.1003 and 607.1006 of Florida Business Corporation Act, OCEAN GROVE, INC., a Florida corporation Document Number P94000094143 (the "Corporation"), in accordance with actions approved at a meeting of its sole shareholder on December 15, 1999 the corporation hereby adopts the following amendment to its Articles of Incorporation:


- 1. Article VII of the Articles of Incorporation of the Corporation is hereby deleted in its entirety and the following is substituted therefor:

ARTICLE VII  
Number of Directors

The business of the Corporation shall be managed by a Board of Directors consisting of not fewer than one (1) but not more than seven (7) members, the exact number to be determined from time to time in accordance with the By-Laws.
