ARTICLES OF INCORPORATION

OF

COMPASS BANK

ARTICLE ONE

The name of the corporation is Compass Bank.

ARTICLE TWO

The Articles of Incorporation of the corporation are amended so that Article II thereof shall read as follows:

The general nature of the business to be transacted by this corporation shall be: That of a general commercial banking business with all the rights, powers, and privileges granted and conferred by the Florida Banking Code, regulating the organization, powers, and management of banking corporations, including without limitation the unlimited right, power, and privilege to exercise trust powers and engage in a trust business, all to the fullest extent and with all rights, powers, and privileges granted and conferred under Florida law.

ARTICLE THREE

This amendment was duly adopted by unanimous action of the corporation's sole shareholder, such that the number of votes cast for this amendment was sufficient for approval, on July 14, 1997.
