Pursuant to Section 607.1006 of the Florida Business Corporation Act, Crossroads Trading, Inc., a Florida Corporation hereby certifies to the Florida Secretary of State that:

FIRST: The name of the Corporation is : Crossroads Trading, Inc.

SECOND: The Charter of the Corporation ("Charter") hereby is amended by striking in its entirety Article 1 and by substituting in lieu thereof the following amendment (the "Amendment"):

ARTICLE I: The name of the Corporation (hereinafter referred to as the "Corporation") is : SportSource International, Inc.

THIRD: The Board of Directors of the Corporation (the "Board of Directors"), by written consent to such action signed by all the members thereof and filed with the minutes of the proceedings of the Board of Directors, adopted a resolution setting forth the Amendment to the Charter declaring that the Amendment was advisable and directing that it be submitted for action thereon by unanimous written consent of the Shareholders of the Corporation (the "Shareholders").

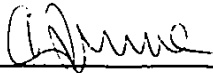
FOURTH: A consent in writing setting forth approval of the Amendment was signed by the Shareholder and filed with the records of the Corporation.

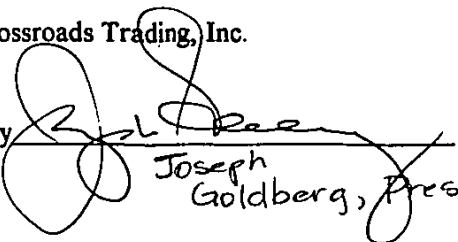
