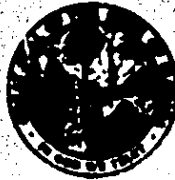

The undersigned subscribers, natural persons competent contract, hereby form a corporation under the laws of the State of Florida, and adopt the following Articles of Incorporation:

ARTICLE 1. - CORPORATE NAME AND ADDRESS. The name of the corporation is: LOGISTICS ASSOCIATES, INC. The principal place of business and mailing address is 890 115th Avenue, Treasure Island, Florida 33706.

ARTICLE 2. - PURPOSE. The corporation is organized for the purpose of engaging in any activities or business permitted under the laws of the State of Florida.

ARTICLE 3. - SHARES. The corporation is authorized to issue ten thousand shares of common stock. Such shares shall be of a single class and shall have a par value of one dollar per share.




