ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of the corporation is Quality Coach Works, Inc., 101 Wellington Street SW, Palm Bay, FL 32907. (Principal Office and Registered Agent).

ARTICLE IL - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any of all lawful business.
