The undersigned, as incorporator of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation.

#### **ARTICLE 1 - Name**

The name of the Corporation is Affordable Wheels of Ft. Pierce, Inc.

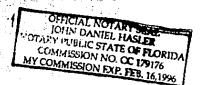
