ARTICLE I - NAME

The name of this corporation is: HOUSE OF BORDEAUX, CORP.

ARTICLE II - DURATION

This corporation is to exist perpetually. It shall commence ~~its existence~~

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting ~~any and all~~

ARTICLE XIII - POWERS


This corporation shall have all powers necessary & convenient to effect its purposes and enumerated in the Florida General Corporation Act.




