ARTICLES OF INCORPORATION

OF

The undersigned, being an individual, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act and the Porfessional Service Corporation and the Limited Liability Company Act, Section 621.

FIRST: The corporate name for the corporation (hereinafter called the "corporation") is SUSAN DENNIS LIS, M.D., P.A.
