ARTICLE ONE

The name of the corporation is A.J.R.C., Inc.

ARTICLE TWO

The period of its duration is perpetual.

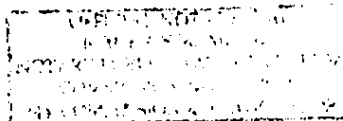
