ARTICLES OF INCORPORATION
OF
PANACEA COASTAL REALTY, INC.

The undersigned, acting as incorporators of this corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation on behalf of the corporation:

1. Name: The name of the corporation shall be Panacea Coastal Realty, Inc. .

2. Principal Office: The principal office of the corporation shall be located at #12 Jer-Be-Lou Boulevard, Panacea, Florida 32346.

3. Duration: The duration of the corporation shall be perpetual.

4. Purpose: The purpose of the corporation shall be real estate and to perform any and all legal acts under the laws of the State of Florida and of the United States of America.

5. Capitalization: The corporation shall be authorized to issue 100 shares of stock, all of one class, with \$5.00 par value per share.

6. Management: The affairs of the corporation shall be managed by the stockholders, who shall elect a President/Sec. annually. A majority of the Stockholders shall constitute a quorum and a majority of the stockholders present shall prevail on any issue. The initial officers shall be:

a. President/Secretary - Walter B. Dickson

8. Amendments: These Articles of Incorporation and the Bylaws of this Corporation may be amended, altered and repealed by a majority vote of the shareholders at any regular or special meeting.

9. Indemnification: The Corporation is authorized to indemnify any present or past officer of the Corporation for any liability for actions taken by them in their official capacities and/or on behalf of this corporation.
