#### ARTICLE I - NAME:

The name of this corporation is: PURI SAKANA OF DESTIN INC hereinafter referred to as the Corporation")

#### ARTICLE II - DURATION:

The Corporation shall exist perpetually, commencing upon the filing of the Articles of Incorporation with the Department of State.
