ARTICLE I

THE NAME OF THE CORPORATION IS:

CHRISTINI'S RISTORANTE ITALIANO INCORPORATED

ARTICLE II

THE REGISTERED OFFICE IN THE STATE OF FLORIDA IS TO BE LOCATED AT 7380 SANDLAKE ROAD, SUITE 500, ORLANDO, FLORIDA 32819. IT IS LOCATED IN THE COUNTY OF ORANGE, FLORIDA.

ARTICLE III

THE REGISTERED AGENT FOR THE CORPORATION IS G. SADDINGTON STEVENS, 5941 CHESAPEAKE PARK, ORLANDO, FL 32819 AND HE ACCEPTS THE RESPONSIBILITIES AS OUTLINED IN THE FLORIDA STATUTES.

ARTICLE IV

THE PURPOSE OF THIS CORPORATION IS TO ENGAGE IN ANY LAWFUL ACT OR ACTIVITY FOR WHICH THE CORPORATION MAY BE ORGANIZED UNDER THE LAWS OF THE STATE OF FLORIDA.

AND DESIGNATED AS CLASS A COMMON STOCK;

AND

100,000 SHARES OF PREFERRED STOCK WITH A PAR VALUE

OF \$ 1.00 PER SHARE AND DESIGNATED AS

CLASS B PREFERRED STOCK.

SAID PREFERRED STOCK SHALL BE ISSUED FROM TIME TO TIME IN ONE
OR MORE CLASSES OR SERIES, WITH SUCH DIVIDEND RATES, VOTING
RIGHTS, RIGHTS OF CONVERSION, RIGHTS UPON DISSOLUTION OR
LIQUIDATION AND WITH SUCH DESIGNATION, PREFERENCES AND
RELATIVE PARTICIPATION, OPTIONAL OR OTHER SPECIAL RIGHTS OR
QUALIFICATIONS, LIMITATIONS OR RESTRICTIONS THEREOF, AS SHALL
BE DETERMINED BY RESOLUTION ADOPTED BY THE BOARD OF
DIRECTORS AT THE TIME SUCH STOCK IS ISSUED.
