ARTICLE I - NAME

The name of the corporation is ----- THE ART OF THE PARTY, INC.

ARTICLE II - DURATION

This corporation shall exist perpetually. Corporate existence shall commence on January 1, 1995.

ARTICLE III - PURPOSE

This corporation is organized for the following purposes:

SPECIAL EVENT SERVICES and shall include the transaction of any and all lawful business for which corporations may be incorporated under State of Florida Statutes.

ARTICLE IV - CAPITAL STOCK


