# ARTICLES OF INCORPORATION

The undersigned subscribers to these Articles of
Incorporation, each a natural person competent to contract,
hereby associate themselves together to form a corporation under
the laws of the State of Florida.

#### ARTICLE I - NAME

The name of the corporation is:

# ARTICLE II - NATURE OF BUSINESS

This corporation is organized for the purpose of transacting any and all lawful business. The main purpose of this corporation is to engage in every phase and aspect of the business of selling and installing air conditioning and heating systems.

### ARTICLE III - CAPITAL STOCK

The maximum number of shares of stock to be issued by this corporation shall be 100 shares at \$1.00 value per share.

# ARTICLE IV- TERM OF EXISTENCE
