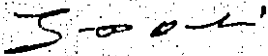

ARTICLES OF INCORPORATION

of

ARTICLE I - NAME

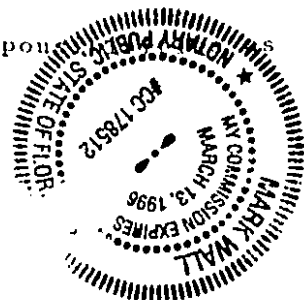
