My accountant recently called me inquiring about my 2004 UBR report. I did not have it and he contacted the State of Florida and discovered that my corporation is inactive, and not current with its filing of the 2003 Uniform Business Report. When he asked the representative from the State what address was on file, he noted that the address of the Registered Agent as well as the mailing address is incorrect. The city in both addresses you have in your system is Hialeah, and should be Miami, Florida. Our address has been the same for many years so I do not know where you got the incorrect address in your system. This would explain our not receiving the 2003 UBR. Being a medical office building, where confidentiality is of up most concern, a wrong suite number, or address, could lead to the mail carrier not leaving correspondence at an incorrect address.

Enclosed please find a new copy of my 2003 Corporate UBR Report. Along with the Report I am enclosing a check for the year 2003 \$150.00 filing fee. I request that you please correct your records to reflect the correct suite number. I respectfully request that the \$600.00 penalty be waved due to the above referenced reason.
