ARTICLES OF INCORPORATION
of

ARTICLE I - NAME

The name of the corporation is ----- COOL WAVES BEAUTY & BARBER, INC.

This corporation shall exist perpetually.

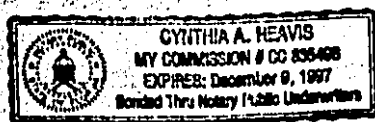
