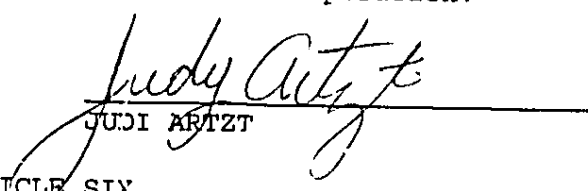
3. To do other such things as are incidental to the foregoing or are necessary or desirable in order to accomplish the foregoing.
