ARTICLES OF INCORPORATION
OF
KCF CONTRACT SERVICES, INC.

THE UNDERSIGNED INCORPORATOR, FOR THE PURPOSE OF FORMING A CORPORATION UNDER THE FLORIDA BUSINESS CORPORATION ACT, HEREBY ADOPT THE FOLLOWING ARTICLES OF INCORPORATION.

ARTICLE I. NAME

THE NAME OF THIS CORPORATION SHALL BE KCF CONTRACT SERVICES, INC.

ARTICLE II. PRINCIPAL OFFICE
