ARTICLES OF INCORPORATION OF

SOUTHERN R.E.B'S. PUBLISHING, INC.

The undersigned Incorporator(s) hereby execute these Articles of Incorporation in order to form a corporation under the laws of the State of Florida

ARTICLE I. NAME

The name of this corporation is Southern R.E.B.'S. Publishing Inc.

ARTICLE II. NATURE OF BUSINESS

The corporation may engage in any activity or business permitted under the laws of the United States and of this State.

ARTICLE III. CAPITAL STOCK
