Dear Justin,

Per our telephone conversation on Tuesday, 13 Aug. 02, I have enclosed a check in the amount of \$485.75 to cover reinstatement costs for Southern R.E.B.'S.

Publishing, Inc. and to receive a certified copy of said reinstatement. Also, I have enclosed documentation demonstrating the lack of ability to file renewals for the years 2000, 2001 & 2002.

Dennis E. Summer is the sole owner and officer of Southern R.E.B.'S Publishing, Inc. At no time since the establishment of this corporation in January 1995 has he given consent for another party to be affiliated in any capacity with Southern R.E.B.'S.

Currently, Mr. Summer is finalizing what has been an extremely lengthy divorce procedure. During this trial, which began in March 2000, it has been brought to his attention unauthorized revisions on the corporate form filed with the State of Florida.

These changes were made in 1998 when Judith L. Sumner, Mr. Sumner's wife at the time, added her name and took the title of Treasurer without his knowledge. This was done after he had filled it out and signed it. She took the initiative to mail this document for her husband as well as the responsibility of collecting mail and handling payment of bills throughout the marriage.

Once the parties separated, Mrs. Sumner continued to retrieve mail from their joint P.O. Box #218 located in San Antonio, FL. She willingly failed to provide this and other crucial documents to Mr. Sumner even after numerous requests. The only restate ment form he has received to date is from 2000, and was then made aware of changes

In light of this information, please accept our check to bring Southern DEB'S Publishing the current.

Also, we would appreciate any effort to prohibit Judith Sumner from attempting to associate herself in any capacity with Mr. Sumner's corporation in the future.
