**ARTICLES OF INCORPORATION**

**ARTICLE I - Name**

The name of this corporation is:

**ARTICLE II - Duration**

This corporation shall exist perpetually, commencing on the date of incorporation.

**ARTICLE III - Purpose**

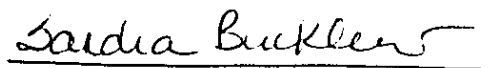
