## ARTICLES OF INCORPORATION

#### <u>OF</u>

#### JANA H, INC.

The undersigned incorporator, for the purpose of forming a corportion under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

#### **ARTICLE I - NAME**

The name of this corporation shall be: JANA H, INC.

## **ARTICLE II - DURATION**

This corporation is to exist perpetually. It shall commence its existence upon filing.

## ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all business permitted under the laws of the United States of America and the laws of the State of Florida.

# ARTICLE IV - CAPITAL STOCK
