ARTICLES OF INCORPORATION 95 JAN-4 PH 4: 23

SECRETARY OF STATE LARGE BLEMSSEE, FLORIDA

The undersigned incorporator to these Articles of Incorporation hereby forms a corporation under the laws of the State of Florida.

ARTICLE I

NAME

The name of this corporation shall be Wreck Diver Ventures of Key Largo, Inc.

ARTICLE II

NATURE OF BUSINESS

The primary nature of business of this corporation shall be providing vessel charters for recreational water sports activities, and any other activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III

CAPITAL STOCK

The aggregate number of shares which the corporation has the authority to issue is 7,000, all of which shall be common shares with par value of \$1.00 per share.

ARTICLE JV

TERM OF EXISTENCE

The corporation shall exist perpetually.

INDEMNIFICATION

Unless otherwise expressly prohibited by the Florida General Corporation Act, and except as otherwise provided in the Foregoing sentence, the Board of Directors of the Corporation shall

have the sole and exclusive discretion, on such terms and conditions as it shall determine, to indemnify, or advance expenses to, any person made, or threatened to be made, a party to any action, suite, or proceeding by reason of the fact that he is or was an officer, employee or agent of the corporation, or is or was serving at the request of the Corporation as an officer, employee or agent of another corporation, partnership, joint venture, trust or other enterprise. No person falling within the purview of the foregoing sentence may apply for indemnification or advancement of expenses to any court of competent jurisdiction.
