ARTICLES OF INCORPORATION

OF

MID FLORIDA AUTO RECOVERY AND IMPOUND, INC.

THE UNDERSIGNED, for the purpose of forming a corporation under the Florida General Corporation Act hereby adopt the following Articles of Incorporation.

ARTICLE 1:

NAME

The name of the corporation is:

MID FLORIDA AUTO RECOVERY AND IMPOUND, INC.

ARTICLE II:

DURATION

The term of the existence of the corporation is perpetual.
