# CERTIFICATE OF INCORPORATION

#### ARTICLE I-NAME

The name of this corporation shall be: WIND & WILLIAMS, INC.

#### ARTICLE II-NATURE OF BUSINESS

This corporation may engage in any activity or business permitted under the laws of the United States or of this state.
