The undersigned, acting as the incorporator of a corporation, as set forth in Chapter 617 of the Florida Statutes, as amended adopts the enclosed Articles of Incorporation for such Corporation

**ARTICLE I**

The name of the corporation shall be **GRAVITY BUILDERS INC.**

**ARTICLE II**

The mailing address and principal place of business is

**ARTICLE III**

The period of duration of the corporation shall be perpetual unless dissolved according to law.

**ARTICLE IV**

The purpose of the corporation is to engage in any lawful act or activity for which the corporation may be organized under the general corporation law of Florida.

## ARTICLE V

The corporation's registered office shall be located at

## ARTICLE VI

The corporation shall have the authority to initially issue ten thousand (10,000) Shares of Common Stock, each share to have a Par value of one dollar (\$1.00). These shares may be issued upon such terms as the Board of Directors may from time to time authorize.

## ARTICLE VII

The share holders shall have preemptive rights unless the Articles of Incorporation are otherwise amended by an amendment to the bylaws according to law.

## ARTICLE VIII

The initial Board of Directors shall consist of two (2) persons. The number of directors may be increased or decreased from time to time by an amendment to the bylaws; however there shall never be less than one (1) director.

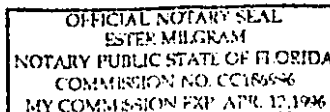
