We, the undersigned, for the purpose of forming a corporation under the Florida General Corporation Act hereby adopt the following Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation is: T & A CONCRETE, INC. The principal office and mailing address is: 11500 Bayshore Road, North Fort Myers, Florida 33917

ARTICLE II: DURATION

The term of existence of the corporation is perpetual.
