# ARTICLES OF INCORPORATION

### QE

### TO THE SUN INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

Article I. Name and Address. The name and address of the Corporation is: To The Sun,/3857 Camino Real, Sarasota, Florida 34239/

Article 2. Duration. The duration of the Corporation is perpetual.

Article 3. Purpose. The general purposes for which the Corporation is organized are the following:
