


The undersigned incorporator for the purposes of forming a professional service corporation under Chapter 607, Florida Business Corporations Act, and Chapter 621, Professional Service Corporation Act, hereby adopts the following Articles of Incorporation:

- FIRST: The name of the corporation is David L. Zedeck P.A. (the "Corporation").
- SECOND: The principal office address and mailing address of the Corporation is 1820 N.E. 163rd Street N. Miami Beach, FL 33162.
- THIRD: The Corporation is authorized to issue 10,000 shares of common stock, par value \$0.01 per share. Shares of the Corporation's stock and certificates shall be issued only to attorneys in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional services as the corporation.
- FOURTH: The street address of the initial registered office of the Corporation is: 1820 N.E. 163rd Street N. Miami Beach, FL 33162 and the registered agent at that address is David L. Zedeck.
- FIFTH: The name and address of the incorporator of the Corporation is David L. Zedeck, 1820 N.E. 163rd Street N. Miami Beach, FL 33162.
- SIXTH: The Corporation is organized for the purpose of engaging in the practice of law in the State of Florida, and all it's fields of specialization as engaged in by attorney pursuant to Chapter 621, Professional Service a Corporation Act. The Corporation shall engage and render the professional services involved only through it's officers, agents and employees who shall be attorneys in good standing, licensed or otherwise legally authorized

within the State of Florida to render the same professional service as the Corporation.

- SEVENTH: The Corporation shall have one director initially and the number of directors may be increased or diminished from time to time as provided in the Bylaws but shall never be less than one. The name and address of the initial director of the Corporation is: David L. Zedeck, 1820 N.E. 163rd Street N. Miami Beach, FL 33162.
- EIGHTH: The Corporation expressly elects not to be governed by Section 607.0901 of the Florida Business Corporation Act, as amended from time to time, relating to affiliated transactions.
- NINTH: The Corporation expressly elects not to be governed by Section 607.0902 of the Florida Business Corporation Act, as amended from time to time, relating to control share acquisition.
- TENTH: The existence of the Corporation shall commence on January 1, 1995 and be perpetual.


