The undersigned incorporator for the purposes of forming a professional service corporation under Chapter 607, Florida Business Corporations Act, and Chapter 621, Professional Service Corporation Act, hereby adopts the following Articles of Incorporation:

FIRST: The name of the corporation is David L. Zedeck P.A. (the "Corporation").

SECOND: The principal office address and mailing address of the Corporation is 1820 N.E. 163rd Street N. Miami Beach, FL 33162.
